

RESOLUTION NO. 2022-08

A RESOLUTION of the Board of Commissioners of South Whidbey Parks and Recreation District, Island County, Washington, providing for the early repayment of the District's unlimited tax general obligation bond issued pursuant to Resolution 2019-06 for the purpose of financing the acquisition, development and improvement of certain real property for recreational use.

**WHEREAS**, at an election held in South Whidbey Parks and Recreation District, Island County, Washington (the "District") on November 5, 2019, the number and proportion of the qualified electors of the District required by law for the adoption thereof voted in favor of a proposition authorizing the issuance of bonds of the District in the aggregate principal amount of not to exceed \$379,000 to provide the funds to acquire, develop and improve approximately 40 acres of real property in the District to preserve and maintain the property for active recreational use (the "Projects") as authorized by Resolution No. 2019-02 of the District adopted on July 30, 2019 (the "Election Resolution") by the District's Board of Commissioners (the "Board"); and

**WHEREAS**, the District issued its Unlimited Tax General Obligation Bond, 2019 in the aggregate principal amount of \$379,000 (the "Bond") pursuant to Resolution 2019-06; and

**WHEREAS**, the current balance of the Bond is \$231,780.29 and after the December 1, 2022 payment, the balance will be \$156,270.24; and

**WHEREAS**, as of December 1, 2022, the early prepayment price of the Bond will be \$234,445.75 (\$78,175.52 + \$156,270.24); and

**WHEREAS**, the Bond is prepayable at any time in whole or in part without penalty; and

**WHEREAS**, the District has sufficient funds from grant revenues and tax receipts to pay off the remainder of the aggregate principal amount of the Bond and all accrued interest to the date of prepayment;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF SOUTH WHIDBEY PARKS AND RECREATION DISTRICT, ISLAND COUNTY, WASHINGTON as follows:

The District Executive Director is hereby authorized to prepay the Bond, in whole, on or before December 1, 2022 using the tax revenues from this year associated with the bond levy and remaining grant funds allocated to this purpose in the total amount of \$234,445.75.
