# **Business Manager's Report**

- The concrete pad that provides access to the dock at Deer Lake (not the new one) has collapsed, as shown in the photos below. There are also patches on the dock itself. I've notified Derek Hacker, our contact at WA Dept of Fish & Wildlife, but haven't heard back. I've also attempted to schedule a Pre-Season Meeting with WDFW and Tom, and to follow up on an invoice for the pumping of the Lakes' vault toilets, but haven't heard back about those either. The damaged dock is not called out in our agreement to maintain the lakes, which goes through October 31, 2025.
- Agreement in progress with Backroads tour group for using District facilities as a launching & gathering point for tours. The group representative seemed generally amenable to the \$1200 fee and conditions of the agreement. The agreement is being reviewed by Backroads' Finance team.
- We are working on creating a Recreation Assistant job description to post as soon as possible. The job should be posted by the board meeting. An updated job description for the Season Maintenance position has been posted. Thank you to the board for increasing our staffing bandwidth.
- The RCO Funding Board will be meeting June 27-28, with Award decisions being made on the 28<sup>th</sup>.
