In addition, all drawing information contained in the electronic information including, but not limited to, symbol libraries, blocks and details may not be reproduced, sold, distributed or utilized in any form on any other project or by anyone else.
- 3. The information is proprietary and is to be used only as an aid toward the successful completion of Project by the Recipient, person and/or company identified below. - 4. Recipient shall have 30 days from receipt of the electronic information to verify compatibility, readability and appropriateness for use. If errors or discrepancies are discovered, please notify our office in writing immediately. MIG shall not be responsible for translation errors and does not agree to maintain the electronic information beyond this time period, nor to translate or reconfigure the electronic information.
- 5. Drawings shall not be interpreted to be true scale documents of the proposed work, nor shall they be utilized for fabrication unless written approval is first obtained from MIG.
- 6. In addition to the other conditions and restrictions contained in this Agreement, use of the electronic information is specially limited to the following: **Pavement extents**, spot elevations, contours, and location of storm drainage system.

- 7. Recipient recognizes that transfer of electronic information, including, but not limited to, file sharing site (e.g. Egnyte, Google Drive, SharePoint, etc.) prepared by MIG, may not be 100% compatible with Recipient's computer system due to differences in computer hardware and software, may be subject to translation errors, and may be subject to undetectable alteration and/or uncontrollable deterioration.
